Dog License Tax Information

Per Wis. Stats. § 174.05, all Town of Brigham residents owning a dog more than 5 months of age on January 1 of any year, or 5 months of age within the license year, shall annually, or on or before the date the dog becomes 5 months of age, pay the dog license tax and obtain a license.

Application Instructions

1. Complete the **Dog License Application** form.
2. **Provide proof of current rabies vaccination.** This must be provided *each* year regardless of whether it was previously supplied. Current rabies vaccination information can be emailed to megan@brighamtown.com.
3. **Provide proof of spaying or neutering**, if applicable.
4. **Enclose a check** (made payable to Town of Brigham)

- Dog License Tax Fees:

- Spayed or Neutered: \$5.00
- Unspayed or Unneutered: \$10.00
- **Late Fee:** Dog license taxes are subject to a late fee if purchased on or after April 1 of the current license year, or after the date the dog becomes 5 months of age.

Do you have to pay a late fee? If you answer yes to *all* these questions, you must pay the \$5.00 late fee in addition to the dog license tax fee:

- Is today on or after April 1?
- Is your pet over 5 months of age as of today?
- Have you had your pet for more than 30 days?
- Have you been a Town of Brigham resident for more than 30 days?

5. **Enclose a self-addressed, stamped business-size envelope** for the return of your documents and your new license.

Notice to Dog Owners:

Wis. Stats. § 95.21 (2) RABIES VACCINATION REQUIRED FOR DOGS. Except as provided in s. 174.054 or sub. (9) (d), the owner of a dog shall have the dog vaccinated against rabies by a veterinarian or, if a veterinarian is physically present at the location the vaccine is administered, by a veterinary technician, pursuant to s. 89.05 (2) (d), at no later than 5 months of age and revaccinated within one year after the initial vaccination. If the owner obtains the dog or brings the dog into this state after the dog has reached 5 months of age, the owner shall have the dog vaccinated against rabies within 30 days after the dog is obtained or brought into the state unless the dog has been vaccinated as evidenced by a current certificate of rabies vaccination from this state or another state. The owner of a dog shall have the dog revaccinated against rabies by a veterinarian or, if a veterinarian is physically present at the location the vaccine is administered, by a veterinary technician, pursuant to s. 89.05 (2) (d), before the date that the immunization expires as stated on the certificate of vaccination or, if no date is specified, within 3 years after the previous vaccination.

Wis. Stats. § 95.21 (10) PENALTIES. (a) *Failure to obtain rabies vaccination.* An owner who fails to have a dog vaccinated against rabies as required under sub. (2) (a) may be required to forfeit not less than \$50 nor more than \$100.
